


Figure 1. Block diagram of Residential Complex Management System.

A. Administrative Panel

This will be the web based application which will be used to create and manage the users. The privileges to use this panel will be given to a trustworthy person suggested by the society member's.

1. Admin Module:

- a. Registers all the Flats and Floors and Wings.
- b. Registers all the owner list
- Sends SMS and Mail to owners for registering to access the site with verification of email ID and Mobile Numbers as verifies.
- d. Admin assigns roles to the owners according to the current titles such as accountants, Secretary, Vice Secretary, assistants, treasurer etc.
- e. Admin verifies if any new transfers of apartment is done through sales. Payment data is mounted.
- f. Monthly payment is calculated as per sinking fund, late fees, processing etc. Monthly reminders to be send to the concerned person every month.
- g. In case the payment is delayed the notice is issued to the person is marked as inward to documents storage.
- h. Monthly electricity bill, water bill, office, guards remuneration, cleaning and others
- Yearly/Quarterly Events, Maintenance such as painting, compound wall, shed building parapet covers, touch up, patch and any unforeseen expenses are mounted.
- j. Albums for events containing the Event Data and pictures or any achievements by pupil will be displayed. Events can be searched.
- k. Meeting notice is issued online. Agenda is also provided in the notice. Post meeting the points of meting is updated in the system and is open to be viewed by others.
- 1. The yearly account release will be activated in the system for a specific period for members to view.
- m. The data is prepared by taking in the consideration financial year audit work.
- n. A List of vendors such as Plumber, Electric, Travel, Medical, Legal, Maid help, packers and movers, Police, Food service will be enlisted for members convenience.
- Secret Ballet: A system for election of members as for society positions will be activated every year. Secret ballet will count the votes and declare result which will be displayed on the site.
- p. List of Society members and Mobile numbers will be listed.
- q. Exit Entry data view updated by guard can be viewed by admin.
